I write further to the FINA memorandum dated 13 August 2020 entitled "QUALIFYING PROCEDURE FOR THE 15TH FINA WORLD SWIMMING CHAMPIONSHIPS (25M) 2021, 13-18 December 2021, Abu Dhabi (UAE)".

In consideration of the difficulties many member National Federations are facing as a result of the continuing COVID-19 pandemic, and following consultation with the President and FINA Technical Swimming Commission, the Qualification Procedure for the 15th FINA World Swimming Championships (25m), that had been rescheduled to 16-21 December 2021, has been extended as follows:

Qualifying Events - see BL 12 3.

Continental Championships, International Competitions and National Competitions held between 1st March 2019 and 28th November 2021.

FINA will only accept entry times which have been achieved at competitions officially approved in advance by FINA.
